



Protocols:

1. On behalf of the Management and Staff of the ICRC, I welcome you all to the 4th Quarter PPP Units Consultative Forum (3PUCF), the last for the year 2023.
2. In the course of the last Quarter of 2023; the Commission as always, successfully issued Outline and Full Business Case Compliance Certificates in respect of key PPP projects from our several MDAs. Between October - December 2023, the Commission issued a total of 15 Outline Business Case (OBC) Compliance Certificates as well as 8 Full Business Case (FBC) Compliance Certificates.
3. Similarly, the Commission secured Federal Executive Council Approval in respect of the Central Workshop Ijora, a project of the Ministry of Works, within the same period.
4. The NII3P, the Commission's training arm has continued to deliver relevant training (Basic, Intermediate and Advance) PPP courses to strengthen the capacity of PPP practitioners and interested members of the public in structuring and delivering bankable PPP projects. In the course of the last Quarter, 2023, the Institute delivered training courses in different parts of the country including an international training which held in Tanzania early in December, bringing the total number of trainings delivered this year to 13. It is expected that two International, as well as, other in-country courses will take place in 2024, including facilitation of the CP3P professional courses of Foundation, Preparation and Execution courses. These are in addition to our MBA and PhD in PPP courses

 - x. Expression of Animal Vaccine Production through PPP
 - xi. Enhancement of Courier Service Project for the NIS
 - xii. The Nigeria Security and Civil Defence Corps Centralized Domestic Staff Management System
 - xiii. The Nigeria Security and Civil Defence Corp Special Services and Private Guards Management System
 - xiv. Rehabilitation/Upgrade of Radiation on Oncology Centre at the University College Hospital, Ibadan
 - xv. Development of a Greenhouse Office Complex Along Hajj Camp Market, Kano
6. FBC Compliance Certificates were issued for the following projects:
- i. Concession of Un-utilized land owned by the Industrial Training fund (ITF) located at Sheik Jafaar road, Doyari, Kano State
 - ii. Construction of a New Commercial Building at Onikan Museum – 500 Square meters
 - iii. Construction of a New Commercial Building at Onikan Museum – 2,245 Square meters
 - iv. Rehabilitation/Upgrade of Hostel Accommodation at the University College Hospital (UCH), Ibadan, Oyo State
 - v. Centralized Domestic Staff Management System
 - vi. Special Services and Private Guards Management System
 - vii. Enhanced Courier Service for Nigerian Passports
 - viii. Production, Supply, Installation and Maintenance of Laison Cupero GPRS STS Smart Water Meter for Billing Elimination and Maximization of Revenue Collection
