1. Introduction

In line with the President's approval and the Federal Government of Nigeria Circular (SGF) Ref. No. 59804/II243 dated July 7, 2025, which applies to Ministries, Departments, and Agencies (MDAs), the Project Approval Board (PAB) will be the body responsible for the approval of PPPs within the approved thresholds.

2. Project Approval Board (PAB)

The Honourable Minister or Chief Executive Officer of the Ministry, Department, and Agency shall inaugurate the PAB of the MDA as its Chairman, while the Head of PPP Unit shall serve as Secretary to the PAB.

To approve PPP projects that have obtained a Full Business Case (FBC) Certificate of Compliance duly issued by the ICRC, authorising the execution of the PPP Agreement.

NOTE:

- i. Any approval granted for Infrastructure or Service PPPs without an "FBC Certificate of Compliance" duly issued by ICRC shall be null and void.
- ii. The terms and conditions of projects certified by the ICRC cannot be altered or changed by the MDA without the written approval of the Commission, except by the FEC.
